1 INTRODUCTION

The Tariff for trust, information, cryptographic and consulting services is a document containing the prices for using the services of “Evrotrust Technologies” AD (Evrotrust) by end users.

The tariff does not include prices for the use of services in integrating the decisions of Evrotrust to different service providers. In these cases, the prices shall be negotiated with the respective provider according to the volume of services used and shall be charged on a pay-per-use basis.

Evrotrust shall provide the services free of charge or for a payment as specified below.

Evrotrust reserves the right to unilaterally change the prices announced in the tariff in compliance with requirements of the current legislation. Change in prices shall not affect the use of services already paid by the customer.

3 PRICES AND CONDITIONS FOR USING REMOTE SERVICES THROUGH A MOBILE APPLICATION

3.1 SUBSCRIPTION USE

Upon remote use of trust, information and cryptographic services through mobile application installed on a smart device of the user, a payment shall be due as specified in this section.

The presented services give the customer the opportunity to pay the cost for the use of the services on a subscription basis. The customer can subscribe on a monthly basis through his/her portfolio for a certain plan including a certain number of services (remote signatures, identifications, document deliveries, etc.), and the amounts shall be paid in advance at customer's choice - monthly, at the beginning of the month, or for a full year.

According to the functionality provided in the appendix, in case the signatures covered by the

subscription have finished, the customer may switch to another plan. Otherwise if the client does not select another plan, he/she should wait for the next subscription period. The customer may also switch to a cheaper plan that shall be activated after the expiry of the paid subscription period.

3.2 METHOD OF PAYMENT


Payment of the subscription plan may be made by the customer in one of the following ways:

- through the portfolio service on the App Store or Google Play. In this case, the subscription amount shall be paid through the bank card associated with the Apple customer or Google account;
- as a value-added service of the mobile operator to which the customer is a subscriber as the value of the services used by the customer is included in the monthly invoice of the customer to the mobile operator for the respective month. This form of payment is available as long as Evrotrust is integrated with the respective operator;
- by crediting through a direct debit of a payment account of the customer upon his prior consent, when Evrotrust has an integration with the respective payment service provider; or
- in another way, available in the application (ePay, PayPal, bank card, etc.) The methods of payment are constantly expanding for the convenience of the customer.

3.3 PAYMENT

The subscription fees payable for the use of the relevant services through the mobile application are as follows:
